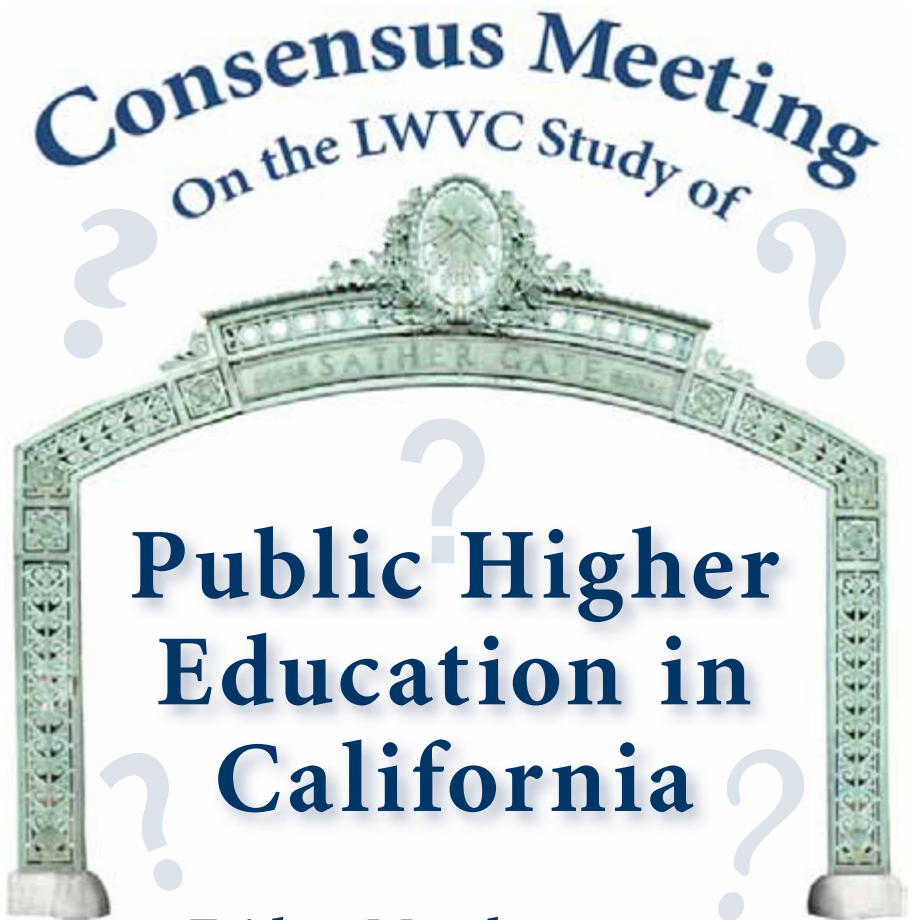

Our *Voter* is an exceptional newsletter of valuable articles contributed and prepared by League members and edited by Cherri Nelson. # Consensus Meeting on Study of Public Higher Education in California



## At the Arab American Cultural Center

Although the League of Women Voters of California (LWVC) had positions on education covering issues in preK-12 and the California Community Colleges (CCC), it did not have a position on public higher education in California inclusive of the CCC, the California State University (CSU), and the University of California (UC) systems. This lack of an inclusive position prevented the LWVC from commenting on or advocating for or against proposed policies and legislation affecting higher education. This study was proposed and approved at the 2013 LWVC Convention to remedy this situation.

A study committee was formed with 15 League members from across the state. The committee began its work in August 2014. The first task completed was a refinement of the scope of the study to “examining access to quality public higher education in California including funding, affordability, preparedness, equity, and opportunities and barriers to student success.”

The State Study Committee reorganized itself into five working research groups addressing each of the identified areas in the scope. Research was completed in March 2015. A smaller writing team of five study committee members synthesized

the more than 150 pages of research and drafted the *Study Guide* and *Consensus Questions*, which were approved by the LWVC Board in August 2015.

Our local League’s education committee (Wade Ellis, Barbara Lea, Ann Roberts, Lois Smallwood, Eleanor Yick) has been meeting since publication of the *Study Guide* and *Consensus Questions* to read and discuss these documents. Members have also written articles about the specific aspects of **access to public higher education California** and posted them in the last four Voters:

- *Update 1: Purpose, Access & Equity*
- *Update 2: Access: Funding & Affordability*
- *Update 3: Why a Focus on Preparedness?*
- *Update 4: Creating Access at Community Colleges!*

We hope all our members have been reading these shorter articles and are prepared to attend and participate in our upcoming Consensus Meeting. ## City & Town Council Observers

**Campbell:** The Council voted unanimously to join nine neighboring cities in a partnership venture bringing green energy to residents and businesses. It is called the Silicon Valley Community Choice Energy Partnership and will provide the option to purchase energy from other providers besides PG&E. The energy offered aims to come from renewable sources, though it will still be delivered through PG&E.

**Los Gatos:** The Council voted 4-1 (Leonardis dissenting) to join the Silicon Valley Community Choice initiative that's being formed to buy clean energy on behalf of local residents and businesses. This Community Choice Energy public/private partnership allows municipalities to purchase renewable or low greenhouse gas-emitting energy at rates that are competitive with PG&E, but with the power delivery and billing still being handled by PG&E. The objective is to take local action to accelerate the reduction in greenhouse gas emissions. The Town approved joining the Joint Powers Authority, which will administer the partnership, and an appropriation of \$150,000 required as their share to support the initial costs of the Authority. The partnership anticipates being able to return these initial funds to the Town over the next few of years. (See the January *Voter* article, page 7.)

There was a unanimously approved vote for strengthening of the Town's medical marijuana ordinance by prohibiting its cultivation, delivery, and dispensing within town limits. The action was in response to the new state regulatory framework that allows municipalities to retain local control over medical marijuana if they act before March 1.

Awarding a bid from Vanguard Construction for the concrete reconstruction of Broadway and Bachman Avenues in the historic Almond Grove district was approved by the Council. The work is anticipated to begin

in May 2016, and to take approximately 6 months to complete.

The town staff was directed to continue meeting with several design professional services that have put forth proposals to design concrete reconstruction of the remaining eight streets in the Almond Grove Street Rehabilitation Project.

Town Council will hear results of vetting these companies at a future meeting. Reconstruction of these remaining streets will be phased in over years 2017-2019.

Story poles and architectural renderings will soon be going up on the southern half of the North 40 plan area (phase 1). They will remain up for 60 days for residents to view. Residents may give commentary to the town Planning Commission. An open house in town council chambers is planned for Feb 23, 2016, to showcase the plan. A scale model is being prepared for display at the council chambers lobby.

**Saratoga:** January 20 – The City Council unanimously voted in favor of the new Silicon Valley Community Choice Energy program. It would give the consumer the opportunity to purchase clean energy, delivered to local homes and businesses by PG&E. Saratoga consumers will be offered low greenhouse gas-emitting energy at low competitive rates. This joint partnership program with PG&E is also offered to the rest of the cities in Santa Clara County—Sunnyvale, Cupertino, Morgan Hill, and Mountain View. Saratoga is also determined to take this option. Saratoga's initial share of the cost will be \$150,000. Further details at [svcleanenergy.org](http://svcleanenergy.org).

## Climate Change Update: Great Decisions Course Highlights Climate Geopolitics

Many of our local LWV members are enrolled in the Great Decisions Class. This course's Study Guide, Chapter 7 - Climate Geopolitics, starts off with an overview of President Obama's visit to Alaska late in August 2015.

Here are some interesting facts about Alaska:

- Warming has been twice as great in Alaska as in the contiguous U.S., during the last 60 years.
- It has the highest erosion rates in the world.
- Wildfire season is a month longer than it was in 1950.
- In the Arctic sea ice covers 40% less water than in 1970.

After reading these facts, I was inspired to see what new information was available and found the following White House announcement:

**Fact Sheet: President Obama Proposes New Funding to Build Resilience of Alaska's Communities and Combat Climate Change**

When the President visited Alaska in August, he described the urgent and growing threat of a changing climate as "a challenge that will define the contours of this century more dramatically than any other." Last year broke the record set by 2014 as the warmest year on record. Climate change is already disrupting our agriculture and ecosystems, our water and food supplies, our energy, our infrastructure, and our health and safety. In no place is this truer than in Alaska. The Arctic is warming twice as fast as the rest of the world and is experiencing the consequences. Higher average temperatures are diminishing the range of winter sea ice, allowing heavy storm surges to batter the Alaskan coastline, and interrupting

the winter hunting season for Alaska Natives, many of whom rely on subsistence to feed themselves and their families.

The President believes we must invest in Alaska's long-term economic and environmental well-being in a way that transcends his time in office. This priority, as well as the President's broader commitment to conservation and climate action – and the economic growth they bring – is evident throughout the President's 2017 Budget..."

There seems to be a lot of information on Climate Change everywhere. I often attend lectures at Stanford and every week there seems to be at least several events on this topic. I hope that many of you take the opportunity to learn more about this important subject...and that you encourage your family and friends to do so also!

## Water: 14 million acre-feet of it – what's not to like?

The State Water Project (SWP) only delivers about **2.3 million acre-feet** of water in an average year, although it supplies some water to about two-thirds of Californians.

Yet the amounts of water that California's water projects currently deliver would not increase—amounts would only be maintained—if the Twin Tunnels Delta Project, now called WaterFix, were built. That was the conclusion reported by the California Department of Water Resources Director, speaking to the Santa Clara Valley Water District Board in January this year. Climate change and ten years of analysis, he said, suggest that the water contractors' original expectations of extra water would not be met, despite the twin tunnels' \$15 billion price tag.

Up to **14 million acre-feet/year** (maf/y), however, could be available sustainably from conservation and various efficiencies, according to an analysis released by the Pacific Institute and the Natural Resources Defense Council. That is more than is used by all of California cities in a year.

Agricultural efficiency alone could yield 5.6 to 6.6 maf/y; urban efficiency might produce 2.9 to 5.2 maf/y; water reuse up to 1.8 maf/y; and stormwater capture up to 630,000 afy.

Our County only uses about **300,000** to 330,000 acre-feet of water a year, according to the Santa Clara Valley Water District. Last year our imported water use was only about 170,000 acre-feet, yet we **pour about 200,000 acre-feet a year** into the San Francisco Bay from South Bay wastewater treatment plants.

A combination of the urban, reuse, and stormwater capture efficiencies described above could dramatically and reliably improve our local water supplies, all the while retaining local control over this valuable resource.

The LWVC supports conservation by all categories of water users, and encourages the reuse of reclaimed water — especially wastewater reclamation to minimize reliance on water exported through and around the Delta. For those and many

other reasons, the LWVC has determined, it cannot support the Twin Tunnels "WaterFix" plan. Let's move forward with sustainable, League-approved alternatives.

## Vote with the League - Yes on Prop 50!

We support Proposition 50 for the June 7 ballot!

- This constitutional amendment would give each Legislature house clear authority to suspend, with a two-thirds vote, a member and withhold pay and benefits.
- A straightforward way for lawmakers to hold their own colleagues accountable for breaching the public's trust.
- Such actions are highly unusual. Over the years, five senators have been expelled, and several senators accused of corruption resigned in 1985. The Assembly has never suspended or expelled a member.

## Two New Positions

Following their January 29-31 meeting, the League of Women Voters board announced a new position, <http://forum.lwv.org/member-resources/article/league-position-adopted-constitutional-conventions-under-article-v-us-const>, calling for safeguards to govern the constitutional convention process and a position, <http://forum.lwv.org/member-resources/article/league-position-adopted-considerations-evaluating-constitutional-amendment>, outlining considerations for evaluating constitutional amendment proposals. The positions were based on consensus reached by 246 local and state Leagues and ILOs who participated in the Constitutional Amendment Process study. Thanks to the Leagues from 46 states that participated in the study and a special thanks to the Constitutional Amendment Process Study Committee headed by Pat Donath of the LWVUS Board, <http://forum.lwv.org/member-resources/article/about-constitutional-amendment-committee>. The positions can be used by state Leagues to address the ongoing debates in many legislatures regarding constitutional conventions, in particular as they relate to the Balanced Budget Amendment.

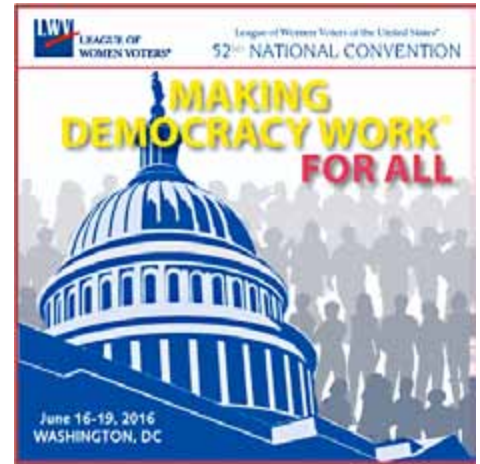

# Legislative Interview with Senator Beall, District 15

Friday, February 20, 2016

## Voting and Elections

**California experienced historically low voter turnout in the 2014 primary and general elections. Many bills were introduced in 2015 to address voter turnout and engagement; a number were passed by the Legislature and signed into law, while some remain on the agenda for 2016.**

**What legislative proposals would you support to improve the number of California citizens who register and turn out to vote? Are there other steps that government should take to engage more California residents in elections?**

“We must focus on education and outreach to raise voter turnout. This dual approach would also increase participation in low propensity voting communities that are often overlooked,” Beall said. He agreed there needs to be a greater emphasis on the use of technology. Senator Beall is open to the idea of exploring on-line voting, but only if it employs state-of-the-art security systems to prevent breaches by hackers. He is confident in Secretary of State Alex Padilla’s plans to modernize outreach programs, as well as the balloting process, from the casting of votes to their collection and accurate tabulation.

## Housing

**Increasing the supply of housing for people of modest means is a vexing problem in California. Underlying the problem is the clash of market economics (when housing is scarce, rents skyrocket) with the strong bonds people form with their homes and neighborhoods. Even if a family doesn’t own their home, they form practical and emotional attachments to what they call home because it impacts every aspect of life—from employment opportunities and friendships to access to good public education and health care.**

**What will you do to ensure that your constituents are not displaced from their homes, and what steps would you take to increase the supply of housing—especially housing that is affordable to people of modest means? Do you agree this would require a stable and dedicated source of funding?**

As Chairman of the Transportation and Housing Committee for the State Senate, Senator Beall is currently working to ensure those who work hard and save should be able to afford a home. In January, he introduced Senate Bill 879, a proposal to spur more affordable housing construction by authorizing the issuance of bonds whose proceeds would be used to finance housing-related programs that serve the homeless and extremely low-income and very low-income Californians.

Last year, Senator Beall introduced Senate Bill 377, which called for modifying the state low-income housing tax credit to increase the value of state tax credits by 40 percent at no additional cost to the state. The bill would have given developers and investors a greater incentive to construct more affordable housing. The bill was passed by the Legislature but vetoed by the Governor, who killed other bills relating to affordable housing.

## Climate Change

**Climate change was a major issue in the first year of the 2015-2016 legislative session. The legislature passed SB350, which requires the expansion of the state’s renewable energy portfolio to 50% by 2030 and an increase in energy efficiency of buildings by 50% by 2030. Similar reductions in petroleum use in vehicles were removed from the bill. SB32, which would have established a target of 80% reduction of greenhouse gas (GHG) emissions from the 1990 level by 2050, was amended to require only a 40% reduction in GHG emissions by 2030 and to weaken the authority of the California Air Resources Board; it was held over as a two-year bill.**

**What are your priorities for state legislation and policies on climate change? Are there other related issues that you feel need to be addressed?**

“I was a co-author of Senate Bill 350 and voted for it in its original form in the State Senate,” Beall said. The bill, introduced by Senate President pro Tempore Kevin de León, called for a 50 percent reduction in petroleum use in cars and trucks; a 50 percent increase in energy efficiency in buildings; and a goal of half of the

state’s power generated from renewable energy by 2030. After amendments in the Assembly, due to pressure from the petroleum companies, SB 350 bill was amended to eliminate the call for a 50% reduction in petroleum.

In Silicon Valley, Beall has focused on bringing BART through San Jose to the city of Santa Clara. He also fought for funding to electrify Caltrain to reduce headways, meet future ridership demands, increase safety, reduce pollution, and to run quieter trains. Beall supports using some of the state’s Cap and Trade dollars to finance large mass transit projects with the potential to slash voluminous amounts of greenhouse gas emissions.

## Local Issue – BART Funding

**What does Senator Beall see happening with state funding for BART to San Jose?**

**Possible follow up: Would SB9 Cap and Trade funds be available?**

Funding for transportation projects such as BART is very competitive. I’ve been vigilant to ensure BART to Santa Clara gets its fair share of state funds. Last year, I advocated for and voted for an additional \$675 million for the project through Cap and Trade program funds. By 2025, Phase 2 of the BART project would reduce GHG emissions reduction 29,171 metric tons per year.

“We need to get more cars off the road and the way to do that is having a smart, effective transportation plan. We need transit that focuses on connectivity, speed and safety,” Beall said. There needs to be a focus on transit, walking and biking – and exploiting the ways we can tie them together—in order to reduce the vehicle miles traveled,” said Beall. “We have to concentrate on ways to weave public transportation into the heart of communities. Better access to transportation has been shown to improve the lives of poor families because it widens their opportunities for employment, education, and health care. By using Cap and Trade funding we are investing in a long-term solution for transportation.”

Last year, Beall’s Senate Bill 9 was signed into law; the bill infuses practicality and speed into the process of building environmentally friendly mass transit projects, such as BART to San Jose. The bill guarantees long-term funding from the Cap and Trade program for eligible projects, eliminating the necessity to apply for financing in phases and the commissioning of repetitive planning studies for each stage.

SB 9 will ensure that Cap and Trade funding is invested responsibly in projects that maximize GHG reductions and meet the goals of AB 32.

### Priorities

**What major issues do you think the legislature must deal with in 2016? What are your personal priorities?**

“I agree with the Governor that the top priority is balancing the budget and having a rainy day reserve,” said Beall. “That does not mean that we can ignore other issues that need immediate attention. The Department of Developmental Services is in a crisis. Homes are being closed, transportation for people with disabilities is being stopped, and beds for the disabled are being removed. Currently, there are 300,000 people with disabilities in the state. We need to address this issue quickly

to help our most vulnerable people. With smart and careful planning, I believe we can balance the budget, make deposits in the rainy day reserve, and begin restoring funding for people with disabilities.”

**Local question–Workmen’s Compensation**  
**What are you doing to bring justice for injured workers as a result of the workers’ comp reform of 2012, since it eliminated due process for injured workers?**

“The workers compensation needs reforms, but I couldn’t support Senate Bill 863

because it was overly complex and rushed through the Legislature,” said Beall. “There should have been more focus on the treatment for injured workers and less on overhead. Medical conditions that are chronic are becoming acute and treatments such as chiropractic and acupuncture were not considered. For example, this has affected policemen and firemen who legally cannot go to work if they are taking painkillers. Even if they want to work, they often retire, which is a more expensive option.”
